

## **Guidelines for Group Registration for Shri Amarnathji Yatra 2026**

The facility of group registration has been made available for Yatris intending to undertake the Yatra in a group of **5** or more up to maximum of **30** members. The individual members of the Group can apply together by registered post to the address below to secure registration for Yatra 2026.

***Address: Chief Executive Officer, Shri Amarnathji Shrine Board, 2nd Floor, Block-III, Engineering Complex, Raj Bagh, Srinagar- 190008***

1. The Application Forms for Group Registration may be sent on the above address from **15th April, 2026** onwards.
2. The last day for receipt of Application Forms for Group Registration by post shall be **20th May, 2026**.
3. Group Registration shall be done on first-come-first-serve basis, subject to the date-wise and route-wise availability of slots.
4. To apply for the Yatra permit under Group Registration Facility, the Group Leader (one of the intending pilgrims of the group) shall have to send the following valid documents in respect of each member of the Group by registered post at the address indicated above:
  - a) Covering letter in prescribed format placed at **Annexure-I**.
  - b) Duly filled-in prescribed application forms affixed with one passport size photograph with clearly mentioning Aadhaar and contact number.
  - c) Original copies of the prescribed Compulsory Health Certificates (CHCs) issued by the Authorized Doctor/ Medical Institutions. (The formats of the Application Form and CHC and the list of Doctors/ Institutes authorized to issue the CHC are available at Shri Amarnathji Shrine Board's website: [www.jksasb.nic.in](http://www.jksasb.nic.in)).
  - d) Yatra Registration Fee: **₹250** per Yatri, **payable only after document verification and Yatra date allotment**, via online payment, direct bank transfer etc. **[Demand Draft (DD) is not required with application]**
  - e) Mailing address of the Group Leader, along with mobile number, and e-mail ID shall be clearly mentioned in **Annexure –I**. Permits shall be sent by post / emailed on the group leader's mailing address / email id.

f) Postal Charges shall be as mentioned below:

<b>No. of persons in a Group</b>	<b>Postal Charges (Rs)</b>
<b>01 to 05</b>	Rs 50/-
<b>06 to 10</b>	Rs 100/-
<b>11 to 15</b>	Rs 150/-
<b>16 to 20</b>	Rs 200/-
<b>21 to 25</b>	Rs 250/-
<b>26 to 30</b>	Rs 300/-

5. No person below the age of 13 years or above the age of 70 years and no lady with more than six weeks' pregnancy shall be registered for the Yatra even if CHC has been issued by the authorised doctor.
6. In case, requisite registration slots are not available on a given date for which Registration has been sought by the Group, the Group Leader shall be contacted and informed about the next available slot.
7. For Yatra 2026, CHCs issued only after 8<sup>th</sup> April, 2026 would be valid for registration.
8. The registered yatri through group registration facility shall have to collect RFID card after biometric eKYC authentication at any one of the centers established at various locations in Jammu & Kashmir Divisions. No yatri shall be allowed to cross access control gate at Domail / Chandanwari without a valid RFID card. Further, yatri shall be allowed to embark on her/ his Yatra only on the day and route for which she/ he has been registered.
9. Shri Amarnathji Shrine Board shall not be responsible for any postal delay.
